The third meeting of the Cook Inlet Harbor Safety Committee (Cook Inlet HSC) Managing Board (Board) was held as a teleconference on 13th August 2015.

Approval of Past Meeting Summaries: The Board approved the meeting summaries from the June 9th and July 7th teleconferences as modified by email corrections. The meeting summaries will be posted on the website.

Port MacKenzie Seat: The Board agreed to leave the Port MacKenzie seat vacant until such time that the Port appoints a representative.

Filling Vacant Seats: The Board agreed that they could fill any vacant seat at any meeting upon receiving a letter of interest from a qualified applicant. A solicitation will be published annually requesting applications for vacant seats and seats opening due to term expirations. They clarified that they are not obligated to fill a vacant seat if they feel that an applicant will not be a good representative for the stakeholders for which the seat was establish.

Appointment of Alternate for Response Organization Seat: The Board appointed Matt Melton to fill the alternate position for the Response Organization Seat.

Contractor Support: The Board discuss the need for professional help in establishing the non-profit, coordinating communications, developing and maintaining a website, preparing meeting summaries, and developing a Harbor Safety Plan. The Board decided to retain Nuka Research and Planning Group to provide this support for the first year, based on Nuka's experience in managing the Cook Inlet Marine Risk Assessment and working with the Convening Committee to establish the CIHSC.

Administrative Support: The Board discuss the need for administrative support until such time as a non-profit corporation is established and administrative capabilities can be assumed by the organization. Mike Munger (Executive Director of Cook Inlet Regional Citizen's Advisory Council) addressed the Board and said that CIRCAC was willing to provide limited administrative support in the interim, including collecting/dispersing funds. This is an extension of the services already provided by the Council to convene the CIHSC. The Board agreed to this arrangement.

Establishing a 501(c)(3) Non-Profit Corporation: The Board discussed the need to establish an Alaska non-profit corporation and register with the IRS as a 501(c)(3) organization. Nuka Research will look into this process through CIRCAC's attorney.

Developing Bylaws: The Board discussed the need to develop bylaws and asked Nuka Research to develop a draft set based on the CIHSC Charter and the bylaws developed for the Arctic Waterway Safety Committee.

Budget: The Board reviewed the draft budget and established the range of the budget for the first year at 40 to 50 thousand dollars based on six meetings and developing a Harbor Safety Plan. It is anticipated that budgets in subsequent years would be less. Steve Catalano agreed to make revisions to the draft budget and circulate for Board input.

Funding: The Board review possible funding mechanisms and identified the most likely funding to be voluntary donations (tax deductible if donated to a 501(c)(3) organization), grants, and appropriations. Marc Bayer and Steve Ribuffo agreed to develop a list of potential donors to solicit for start-up funding donations.

First Meeting of the CI HSC: The first meeting of the full CIHSC was set for 22 September 2015 at the Port of Anchorage. Steve Ribuffo will draft an agenda and circulate to the board for input.
